

# THE SAINSBURY VETERANS WELFARE SCHEME



Does someone you know need help to live independently?

Would a walk-in shower or stair-lift help?

THE SAINSBURY VETERANS WELFARE SCHEME may be able to help acquire these, and other essential items

## The Welfare Scheme is a registered charity that is supported by the Sainsbury Family Trusts as well as J.Sainsbury plc.

The aim of the Scheme is to provide financial support to Veterans who need help with buying essential items to assist them in maintaining independence in and around their homes, thereby enhancing the quality of their lives.

Such essential items might typically, but not exclusively, include kitchen appliances, bathroom aids including walk-in showers, electrical items, stairlifts, rise & recline beds and chairs, and mobility aids.

Grants are also available for respite care and convalescence when medically recommended. Support is not available for residential or nursing home costs nor towards costs such as private medical and funeral expenses, or repaying debts.









## WHO CAN BENEFIT FROM THE WELFARE SCHEME?

Application for grants can be made by Sainsbury Veterans, their spouses and partners and surviving spouses and partners. Having given priority to the above, grants may also be available to other former Sainsbury employees.

#### WHAT ARE THE RULES OF THE SCHEME?

Applicants will have to provide evidence of need which will usually be a letter or other documents from their doctor, hospital or another qualified person. This will need to detail the specific problem or illness from which they are suffering and the recommended aids or appliances that would improve the quality of their life.

There are financial limitations in the rules of the Scheme so, in assessing the degree of support that can be provided, the applicant will be required to make a declaration regarding their financial position, including savings and investments, but not including their home.

### **HOW TO APPLY FOR A GRANT**
